## Baseball / Softball Field Standard Use Contract

### I. Liability and Hold Harmless

By signing this Agreement, the below organization or individual and all participants agree to waive any and all claims arising out of the use of the Harrisville Borough facilities. This includes, but is not limited to, claims for personal injury and property damage. The organization or individual further agrees to indemnify and hold Harrisville Borough and its members harmless from all claims or demands that may arise out of the use of Harrisville Borough property.

### II. Field Rules

The renting organization agrees to abide by and uphold the following rules:

- Give priority and courtesy to pedestrians on the trail
- The use / possession of alcohol on the premises is prohibited
- Firearms are prohibited
- Glass containers are prohibited
- No batting without a helmet allowed anywhere. BAT IN HAND = HELMET ON HEAD
- Helmets not required for softball
- Smoking or vaping is prohibited
- No parking allowed inside the fenced complex area.
- Abide by Handicapped Parking designations

### III. Field Care Guidelines

The renting organization agrees to abide by and uphold the following guidelines:

- A charge of \$10.00 per league player per season shall be assessed. Names, teams, etc. shall be provided to Harrisville Borough in electric or hard copy format prior to, and during, the season, as needed.
- Remove all trash from dugout and spectator areas when event is concluded and place in provided trash receptacles.
- Portable pitching mounds shall be removed from the field of play
- Bases are to be remove after use and shall be stored in metal storage box by the field. Base plugs shall be installed after bases are removed.
- All activities shall be concluded by 10:00 p.m., unless special permission is obtained, in writing, from Harrisville Borough
- For field repair that is needed, report this matter to the Borough Office at 724.735.2222
- A \$100.00 charge shall be levied by the Borough for any equipment, garbage, or other debris left on the field, dugouts, or bleacher areas

#### IV. Proof of Insurance

No use of Harrisville Borough facilities may occur prior to Harrisville Borough verifying that the organization or individual has adequate insurance. A current copy of the insurance policy in electric or hard copy format shall be provided to Harrisville Borough.

#### V. Tournaments

Tournament organizers must carry tournament insurance. Harrisville Borough shall be listed on certificates of insurance in all cases.

For Little League Use Only:

Little League is bound by all the above verbiage in addition to the following:

- Provide Harrisville Borough with a list of all volunteers, and make volunteers clearances upon request.
- Enforce field rules and field guidelines
- Line all fields
- Provide porta potties for players and spectators
- Maintain concession stands
- Coordinate all field construction and maintenance with Harrisville Borough
- Carry and provide proof of general liability insurance with a minimum of one million dollars (\$1,000,000.00) per occurrence and two million dollars (\$2,000,000.00) aggregate naming Harrisville Borough as additional insured.
