ORDINANCE NO. 1-98

AN ORDINANCE FOR THE PURPOSE OF VACATING ALLEY WAYS WITHIN THE HARRISVILLE BOROUGH MUNICIPAL LIMITS AND PROVIDING FOR REVERSION OF LAND TO ABUTTING OWNERS.

BE IT ENACTED AND ORDAINED by the Borough of Harrisville, County of Butler hereinafter called Municipality, Butler County, Pennsylvania, and it is herein enacted and ordained by the authority of the same as provided under Title 53, Section 46741, as follows:

Section 1 - It is hereby ordained that the following alleyways are vacated by the Borough of Harrisville, to wit;


a - The 20 foot wide alleyway located between lots S2-A7 and S2-A8, said lots being currently owned by the Methodist Episcopal Church of the Society of Harrisville.

Section 2 - The Borough Council and the appropriate Borough offices are hereby authorized to execute any and all appropriate documents to have these alley abandonments filed on public record at the Butler County Court House in the Recorder of Deeds Office of Butler County, Pennsylvania. Said filings to provide for public record versions of land interest purposes to abutting land owners.

Section 3 - This ordinance shall become effective forty (40) days after its full advertisements which shall be its effective date, and notices pursuant to Section 46741 of Title 53 Purdon's consolidated Statutes shall be given as directed.

Section 4 - A copy of maps evidencing the general location of the proposed alleys to be vacated are attached as Exhibit A and made a part of this ordinance.

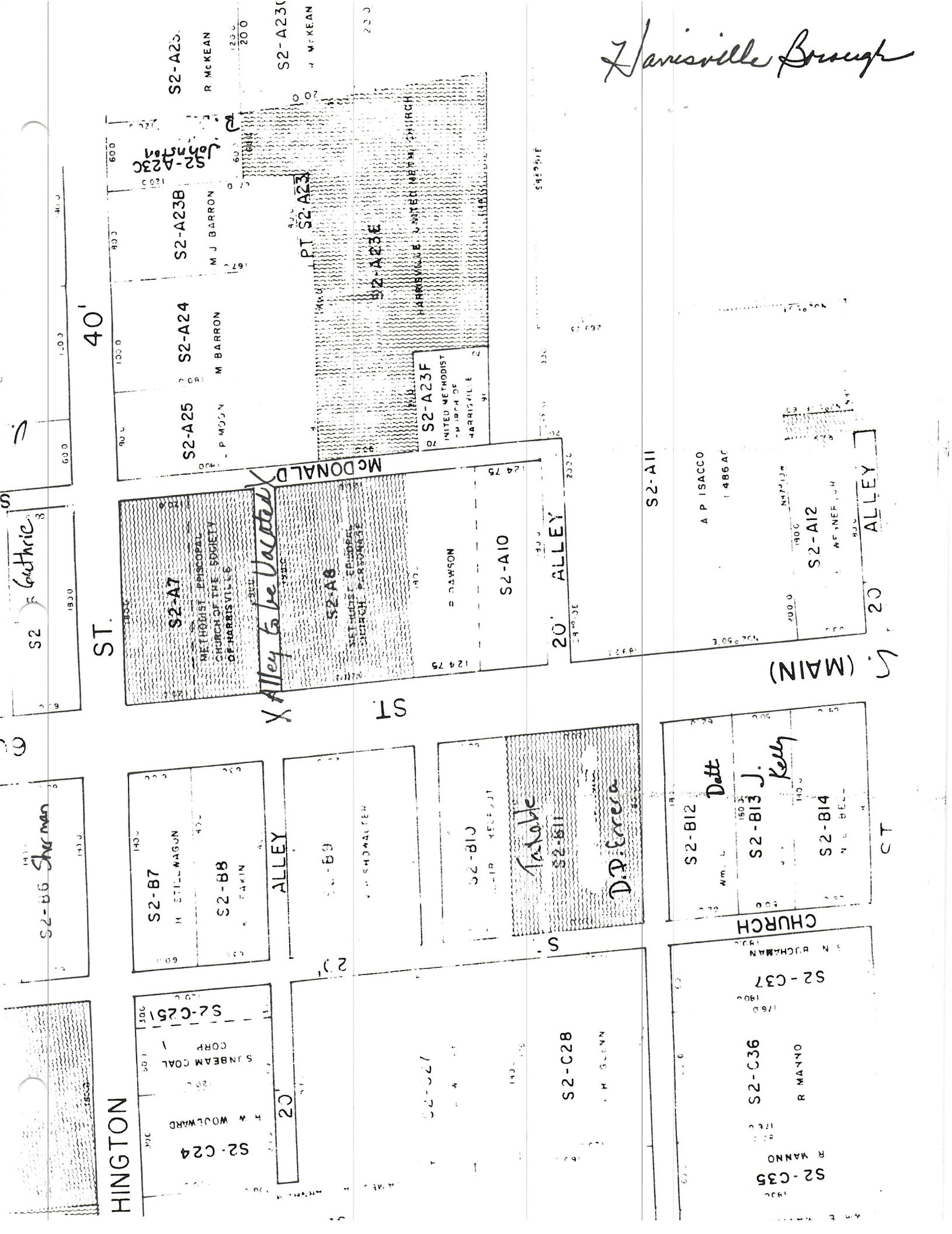
