

**AMENDMENT TO ORDINANCE NO. 2-86 – SEWER USE ORDINANCE**

**AN ORDINANCE AMENDING PART 5 – ENFORCEMENT – SECTION OF ORDINANCE NO. 2 OF 86 – SEWER USE ORDINANCE – WHEREBY THE REQUIREMENT OF A PROPERTY TO PASS INSPECTION OF ALL SEWER SERVICE LATERALS AND CONNECTIONS PRIOR TO SALE OR TRANSFER OF THAT PROPERTY IS AMENDED AS REGARDS TO SEWER USE IN THE BOROUGH OF HARRISVILLE, COUNTY OF BUTLER, COMMONWEALTH OF PENNSYLVANIA.**

**AND NOW, THEREFORE, BE IT ORDAINED AND ENACTED** by the Council of the Borough of Harrisville as follows:

**PART 5 – ENFORCEMENT**

**Section 1:** A new Section 5.1 shall be added to Part 5 – Enforcement of Ordinance No. 2 of 86 which new Section shall read as follows:

No less than thirty (30) days prior to the sale or transfer of ownership of any property served by the Borough of Harrisville Sanitary Sewer Collection System, the owner(s) thereof shall notify the Borough Secretary in writing of the proposed sale or transfer. The Borough Engineer or its designee shall within five (5) days of the receipt of said notice inspect the sanitary sewer service lateral and all connections serving said property to determine that the same are in proper working order and in compliance with all applicable ordinances and regulations. Within five (5) days of said inspection, the Borough Engineer or its designee shall issue a certificate certifying that the lateral and all connections are in proper working order and compliance or identifying all corrective measures necessary to bring the same into proper working order and compliance. The property owner(s) shall at their expense perform all such corrective measures prior to the transfer of the property. Any property owner who violates this provision of this ordinance shall be subject to penalties set forth in Part 5 of this ordinance.

**Section 2:** The section originally numbered 5.1 shall be re-numbered as Section 5.2.


**Section 3:** The section originally numbered 5.2 shall be re-numbered as Section 5.3.

**Section 4:** The section originally numbered 5.3 shall be re-numbered as Section 5.4.

All ordinances or parts of ordinances inconsistent herewith are hereby deemed to be repealed to the extent of the inconsistency and for the purposes of enforcement of this amendment.

This ordinance shall be effective as of June 6, 2011, ORDAINED AND ENACTED this 6<sup>th</sup> day of June, 2011.
