

**AMENDMENTS TO ORDINANCE NO. 1-2000
RECREATIONAL VEHICLE ORDINANCE**

AND NOW, THEREFORE, BE IT ORDAINED AND ENACTED by the Council of the Borough of Harrisville as follows:

SECTION III – DEFINITIONS

Section 1: Section III L. of Ordinance No. 1 of 2000 – Recreational Vehicle Ordinance – is amended to read as follows:

“REGISTERED VEHICLE” means all ATVs and snowmobiles used within the Borough of Harrisville.

SECTION IV – REGISTRATION

Section 1: A new Section IV shall be added to Ordinance No. 1 of 2000 which new Section shall read as follows::

All ATVs and snowmobiles must be registered with the Borough of Harrisville and with the Department of Conservation, as applicable. Each ATV and snowmobile to be operated in the Borough of Harrisville must be registered each year to be accompanied with the payment of a Five (\$5.00) Dollar registration fee per vehicle. The owner of each vehicle must provide his/her name, address, telephone number, date of birth, social security number, each intended user’s name, each intended user’s driver’s license, and a full description of the vehicle, including the vehicle identification number. Said registration is to be kept by the Borough of Harrisville Police Department.

Section 2: The section originally numbered as Section IV will now be re-numbered as Section V.

Section 3: The section originally numbered as Section V will now be re-numbered as Section VI.

SECTION VI – DESIGNATED SNOWMOBILE AND ATV ROADS

Section 1: The following paragraph shall be the amended version of Section VI of ordinance no. 1 of 2000 – Recreational Vehicle Ordinance – reflecting the change therein:

The council hereby designates all streets within the Borough of Harrisville to be available for use by snowmobiles and ATVs.

Section 2: The section originally numbered as Section VI will now be re-numbered as Section VII.

Section 3: The section originally numbered as Section VII will now be re-numbered as Section VIII.

Section 4: The section originally numbered as Section VIII will now be re-numbered as Section IX.


Section 5: The section originally numbered as Section IX will now be re-numbered as Section X.

Section 6: The section originally numbered as Section X will now be re-numbered as Section XI.

All ordinances or parts of ordinances inconsistent herewith are hereby deemed to be repealed to the extent of the inconsistency and for the purposes of enforcement of this amendment.

This ordinance shall be effective as of June 6, 2011, ORDAINED AND ENACTED this 6th day of June, 2011.
